Ferenc Besze's Painting In Watermedia XVII

Congratulations to Ferenc Besze, whose painting, "San Francisco Chinatown," was selected by John Salminen, AWS-DF, NWS, for inclusion in International Watermedia XVII.

This year 494 works were received for consideration. The 185 submitting artists represented three continents, including 36 states and provinces from throughout the United States and Canada, and five countries outside North America. Of these, 90 were selected for the exhibition. Only 18% of the paintings entered were selected.
