The Annual Show will be here before we know it, so I hope you are all thinking about what you want to enter; the subject, the medium, the category, etc. Sometimes it is refreshing to try something new. You never know, it could turn out to be the best you have ever done.

One thing we all need to keep in mind is the rules for entering artwork into a show. We each need to refresh our memories as to our own responsibilities when entering a show. Please reread the instructions for entering when you receive the forms. Carrie usually sends them out each time.

Many of us paint with a group of friends and we often comment on each others' paintings, but this is not the same as having a teacher instructing us. Class work has always been unacceptable in an SWA show. Neither is something that is copied from a magazine or any published work acceptable. Remember that the total work is judged, so make sure that your frame is in good shape and goes well with your painting. Once, in another group, I just missed out on a Best of Show Award because one judge did not like my frame. Framing is important.

We always need people to volunteer to work at show receivings. This is the way for new members to learn how things work and just how the judging works. It is also a great way to meet the other members and artists. When you work a full shift you get your second painting entered free, an excellent incentive to volunteer. It is always fun to work together for a common goal.

Terry Miura

Terry Miura graduated from Art Center College of Design in 1990 and worked in New York City for six years. His first gallery show, city scenes of New York, was in 1995. He returned to California and settled in Fair Oaks where he turned to landscape painting.

Terry's demo will be in oils. He says, "I'm interested in the language of landscape painting and how I might use it to explore the mysteries of emotions, memories and identity. To that end, Miura does not limit himself to painting traditional landscapes. "I'm looking for subtle emotional responses," he explains. "I don't get that from just trees and rivers. Buildings, people, atmosphere, light...any subject can trigger an emotional response. I'm perpetually trying to figure out what that trigger is."

Claire Schroeven Verbiest is a Belgian native who lived in the Congo and in Germany before moving to San Jose, California. An award-winning artist and a signature member of several art societies, Verbiest is considered one of the finest watercolor and pastel artists in the San Francisco Bay Area. In 1999, her painting, "Haute Cuisine," received the High Winds Medal at the American Watercolor Society's annual exhibition.

Claire is well known for her lively, crisp and truthful depictions of people, landscapes, flowers and objects and for her distinctive use of color. She teaches watercolor and pastel painting classes and conducts painting workshops throughout the US, Canada and Europe. She frequently serves as a juror for local art shows. The Triton Museum of Art in Santa Clara, California displayed 29 of her original pastel paintings in May and June of 2007.
