President's Message-SFC

Subject: Art Education. What should an educated person know about art? What experiences should such a one have? What should be included in a solid curriculum? Should this set of experiences be available to all students? Should some or all of it be taught in high school?...college? For example, I often see illustrations in newspapers and magazines that betray the fact that the artist had never been taught the principles of linear perspective. Would you expect a student graduating from an accredited school to have a pretty good knowledge of the history of western art? Some exposure to Asia and Africa should be included. Or is the field just too broad, and anyway, is it more important that they be excited about some aspect that will propel them on to more discoveries on their own?

I am a little put off when an artist says, "I don't do watercolors" or "I don't do oils," or pastels, or pen and ink, etc. I would hope that they would have at least tried each one of the media in school, and have experienced some of the special pleasure each has to offer.

So we have art history, media. Now, there is in the art experience something I call kinesthetic learning, that is, knowledge that seems to be "in the fingers." The feel of things and a degree of mastery.

So much of life these days seems to be beyond our control. When one takes a little piece of something and turns it into something that pleases him/her and perhaps others as well, there is a satisfying sense of control over at least that portion of life.

Another question presents itself: Are we blowing in the wind when electronic means of image making and distributing are taking over?

Think about it. As education is funded and cut, can we make the case for Art as part of all persons' education? Let's come to the the table with solid, constructive answers.

I'd like to hear what you think. Keep painting and learning!
