- 2. Asking your guests/visitors to choose their favorite painting and vote (using the ballot and ballot box) gives them ownership in your gallery and the artwork that you hang.

- 4. When asking each and every guest/visitor (children included!) to vote for their favorite painting, you (SWA) allow them to discover and explore each and every painting, spending more time in the gallery to create a "comfort zone" for them.
